As per reference 1st cited, sanction was accorded to the Principal, Lisie College of Nursing, Lisie Hospital, Ernakulam to admit student for B.Sc. Nursing Programme in that institution during the academic year 2019-20 with an intake of 50 students. As per reference 2nd cited, the Government has sanctioned **enhancement of seats from 50 to 70** on condition that the said college should stop GNM Programme or reduce the number of GNM Seats from 50 to 30 per annum from the academic year 2019-20. As per reference 3rd cited, the Chief Executive Trustee remitted fees and requested for Seat Enhancement. As per reference 4th cited, the Chief Executive Trustee has informed that they have admitted only 30 students for GNM during the academic year 2019-20.

The Commission of the Kerala Nurses and Midwives Council inspected the institution on 04-09-2019 and submitted report. The inspection report was scrutinized and placed before the Kerala Nurses and Midwives Council held on 25-09-2019. The Council resolved to accord sanction to enhance the number of seats from 50 to 70 during the academic year 2019-20.

In the circumstance stated above, sanction is hereby accorded to the Principal, Lisie College of Nursing, Lisie Hospital, Ernakulam for the admission of B. Sc. Nursing Programme with an annual intake of 70 students during the academic year 2019-20 subject to the condition that the said college should stop GNM Programme or reduce the number of GNM Seats from 50 to 30 per annum from 2019-20 onwards.

The Management should strictly follow the guidelines of the Government and the University for conducting the Programme. The Management should also follow strictly the norms prescribed by the Indian Nursing Council and the Kerala Nurses and Midwives Council for conducting the Programme. The Management should obtain affiliation from the Kerala University of Health Sciences, Thrissur for the additional seats sanctioned. The Management should obtain separate order from the Kerala Nurses and Midwives Council to admit the next batch of students during the academic year 2020-21.
