### ORDER

As per paper read (1) above, the University invited applications for Continuation of Provisional Affiliation for the Academic year 2019-20 from colleges for courses affiliated to this University. The Principal of Lisie College of Nursing, Ernakulam has submitted application and remitted required fee for the Continuation of Provisional Affiliation for the year 2019-20.

2. The Governing Council vide paper read (2) above had decided to conduct inspections for granting continuation of provisional affiliation in every two years in all colleges except those colleges where first batch of U.G/P.G/Super speciality courses has not passed out. In such colleges the inspection will be conducted in every year till the first batch has passed out. The Governing Council also decided to conduct random inspections in colleges against whom complaints are received/deficiencies are reported, as and when required. Since the first batch of the college has been passed out and no deficiencies were pointed out in the Previous Year, Inspection for granting Continuation of Provisional Affiliation for the year 2019-20 was not conducted in the college.

3. The whole matter was placed before the 51<sup>st</sup> Governing Council and the Governing Council vide paper read (3) above decided to grant Continuation of Provisional Affiliation to the below mentioned Nursing Colleges for the courses and annual intake mentioned against each for the Academic year 2019-20 subject to receipt of renewal permission from the Central/State Councils :

4. The college has submitted renewal permission from the State Council for the Year 2019-20. The College reported that they have constituted College Council.

5. University vide paper read(4) above, has decided to grant Continuation of Provisional Affiliation for the year 2019-20 to otherwise eligible Nursing Colleges based on the approval from Kerala Nurses and Midwives Council and in anticipation of approval for such colleges from Indian Nursing Council.



The college requested the University for permanent closure of 30 seats of basic B.Sc.Nursing course and University vide order(5) above granted permission for such permanent closure.

Sanction, has therefore been accorded by the Hon'ble Vice-Chancellor by implementing the decision of the Governing Council read (3) above to grant Continuation of Provisional Affiliation to Lisie College of Nursing, Ernakulam for conducting B.Sc.Nursing course with an annual intake of 50 students during the Academic year 2019-20 subject to the conditions detailed below:-

1. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
2. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the Colleges will be initiated.
3. Affiliation granted is strictly provisional and only for the academic year 2019-20. The colleges have to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
4. The Colleges should remit annual administration fee fixed for UG course for the academic year 2019-20.
5. Admission to the next academic year shall be made only after obtaining prior permission from the University.

Orders are issued accordingly.
